Vacancy Description:

An exciting opportunity has become available to join the board of Heritage Lab CIC as a Treasurer & Non-Executive Director.

In summary and working with the Finance Officer and Chief Executive Officer, the position is to maintain and improve our company's financial standing and collaborate with colleagues to assess and manage financial risks.

Reporting to the Chair, this is a key strategic position within the Board, enabling us to grow as an organisation, add value to our local community and support our creative regeneration projects with a particular focus on Ramsgate.

We have recently bought the Old Wine Warehouse in Charlotte Court, Ramsgate and launched the upper floor as Ramsgate Works, a co-working space. The other two floors will be opening shortly. We are therefore at an exciting part of our organisational journey.

We need a treasurer that can help us to make a difference to our community by taking a lead on the following:

- Oversee the financial affairs of the organisation and ensure they are legal, constitutional and within accepted Community Interest Company accounting practice.
- Ensure proper records are kept by the executive and that effective financial procedures and controls are in place.
- Appraising the financial viability of plans, proposals and feasibility studies.
- Monitor and report on the financial health of the organisation.
- Oversee preparation of budgets, accounts and financial statements, and present these to the board, putting in controls and ensuring the organisation is fully compliant.
- Liaise with relevant staff, Board members and/or volunteers to ensure the financial viability of the organisation.
- Make fellow Board members aware of their financial obligations and take a lead in interpreting financial data to them.
- In conjunction with the finance officer, regularly report the financial position at Board meetings.
- Oversee the production of an annual budget and propose its adoption

- Maintain an up-to-date working knowledge of financial and legal regulations that may affect company decisions or policies
- To work closely with the Finance Officer (presently a part time post); to help and assist the development of internal policies and procedures.

Heritage Lab CIC was established to unlock the social and economic potential of historic buildings and community assets. In 2017 our founder led the project with Historic England, local councils and several community organisations to ensure that Ramsgate was the first place in the UK to be established as a Heritage Action Zone. Many of its 450 listed buildings are in a state of poor repair, empty or underused; yet they could represent a powerful tool in the regeneration process. Focusing mainly on the expanding creative sector, we will use our skills and expertise, and those of our partners and community; to bring Ramsgate's heritage buildings and community assets back into sustainable use, creating high quality community space, workspace and jobs and enhancing pride in our town. Complementing other regeneration initiatives, we believe this will reinforce a sense of community, rejuvenate the local economy and provide a catalyst for improvements to the wider area.
